**9. ADDENDUM**

- A. The Board will consider approving a purchase and sales agreement for 12 acres of land located at the northwest corner of the future Fry Road and the future Longenbaugh Road. [This item may be discussed in closed session pursuant to 551.072].
- B. The Board will consider approving the execution of an interlocal agreement with North Harris Montgomery Community College District that provides for granting by the College District of utility and access easements necessary for the construction and operation of the Richard E. Berry Educational Support Center in exchange for the appraised value of the easements and a portion of the landscaping maintenance along the easement area. [This item may be discussed in closed session pursuant to 551.072].

## CLOSED SESSION

There will be a closed session in accordance with Government Code Section 551.001 et seq.

- Section 551.071 For the purpose of a private consultation with the Board's attorney on any or all subjects or matters authorized by law.
- For the purpose of consultation with the district's attorney concerning matters on which the attorney's duty to the district under the Texas Disciplinary Rules of Professional Conduct clearly conflicts with the Texas Open Meetings laws
- Section 551.072 For the purpose of discussing the purchase, exchange, lease or value of real property.
- Section 551.073 For the purpose of considering a negotiated contract for a prospective gift or donation.
- Section 551.074 For the purpose of considering the appointment, employment, evaluation, reassignment, duties, discipline or dismissal of a public officer or employee or to hear complaints or charges against a public officer or employee.
- Section 551.076 To consider the deployment, or specific occasions for implementation, of security personnel or devices.
- Section 551.082 For the purpose of considering discipline of a public school child or children or to hear a complaint by an employee against another employee if the complaint or charge directly results in a need for a hearing.
- Section 551.0821 For the purpose of deliberating a matter regarding a public school student if personally identifiable information about the student will necessarily be revealed.
- Section 551.083 For the purpose of considering the standards, guidelines, terms or conditions the Board will follow, or instruct its representatives to follow, in consultation with representatives of employee groups in connection with consultation agreements provided for by section 13.901 of the Texas Education Code.
- Section 551.084 For the purpose of excluding witness or witnesses from a hearing during examination of another witness.
