
# Who to Contact

#### **Backpack & ID Badge Guidelines**



**Backpacks** must be **clear**. Students shall limit belongings outside of the backpack to only **two** 6"x9"x5" non-clear bags, such as a purse, lunch box, or pencil bag.

Non-clear backpacks (including mesh) will be confiscated and the parent/guardian will need to pick it up from the AP office within two weeks of being confiscated.

The <u>first</u> ID badge, lanyard and plastic sleeve will be issued free of charge and **MUST** be worn all day. No exceptions!

### **Attendance**

\*It is very important for students to attend school daily for the entire day. Our doors open at 7:30 a.m. and first period begins at 7:45 a.m. Students arriving to class between 7:45–7:55 a.m. will be counted tardy.

\*Parents must send a note within three days of an absence for the absence to be excused. Parents will receive letters about excessive absences and/or tardies which could result in a court warning or fine, and/ or loss of course credit. Students who are **more than 10 minutes late** for a given class period will be counted absent for attendance purposes.

**Early Departure:** If you need to pick up your student during the school day, please send a note to the *Attendance Office* no later than 2:50 p.m. with the following information:

- · Name of your student
- · Time for the early pick up
- · Reason for the early departure
- · Name of person picking up.

A parent/guardian or approved emergency contact must present their driver's license and sign him/her out from the Front Office.

# **Home Access Center/Schoology**

Home Access Center and Schoology are tools for parents and students to track academic progress and stay informed of classroom assignments.

# **Arrivals & Departures**

#### **Drop Off/Pick-Up:**

Students should *not* arrive earlier than 7:30 a.m., as we do not have personnel to ensure their safety and welfare prior to that time.

Parents must drop off students by **7:40 a.m.** and pick up students by **3:15 p.m.** in the front of the building (Mills Rd. side).

#### **Departures/After School:**

Students must exit campus immediately after the final bell at 3:10 p.m. For safety purposes, students are *not* permitted to stay afterschool to attend extracurricular events such as football/basketball games.

Unless participating in tutorials, car riders must report to the front of the building to be picked up.

To ensure your students safety, the MET Parking Lot/Bus Ramp are not drop off/pick up locations.

#### **Bus Riders:**

Students must ride their bus assigned by the CFISD Transportation Department.

### **Walkers and Bike Riders:**

Bike racks are available (Mills Rd. side).

#### **After School Tutorials:**

Students must have an official "Afterschool Tutorial" pass from their teacher *prior* to 3:10 p.m. to stay after school. Teachers will pick-up and escort students to their classrooms.

After tutorials, students are expected to wait in the front of the building for their ride or report immediately to Study Hall (with their tutorial pass).

# **Extra-Curricular Attendance**

Students must:

- -go home and return for the start of the game/event.
- -not have received any disciplinary consequences the week prior, and up to the date of the event/game.
- -be cleared of all fines & fees prior to purchasing tickets online and before entering the game/event.
- \*All outstanding fines & fees are sent to parents weekly from the "Bleyl Library email" and includes all badge and misc. fees.
- \*Students must be picked up immediately at the end of games/events in order to attend them in the future.

### **Chromebooks**

Students are required to bring their Chromebook and charger daily. Please make sure they are charged each day. For technology issues, please visit Happy Fox at **my.cfisd.net** to report issues.

\*Reminder: Cell phones are <u>not</u> allowed for instructional purposes.



# **Student Dress Code**

Appropriate student dress and grooming are important factors in the safe and orderly operation of school. Each student's appearance should reflect a positive image of Bleyl Middle School and contribute to a distraction-free learning environment.

General guidelines are as follows:

- Students are not to wear clothing that is tight, loose, sagging, baggy, revealing, spaghetti-strap, backless, low cut or short.
- Clothes must not reveal underclothing.
- Tops, shirts, and blouses must not reveal underclothing, midsection, torso, back, chest, breast, or cleavage.
- Shorts, skirts, and dresses must be mid-thigh in length or longer.
- No type of head covering is to be worn with the exception of religious or medical purposes.
  - o For the safety of identification purposes, hoodies and hats are not allowed and will be collected if worn on campus.
  - o Parents/Guardians will need to pick-up confiscated items within two weeks of the confiscation.
- Students may not wear clothing with visual or written messages that may cause a disruption to the school environment.
- Shoes must not detract from, or interfere with, the learning environment or present a safety or health hazard. House shoes/slippers of any kind are not allowed.
- Pajamas are prohibited.

# **Electronic Device Expectations**

Students are prohibited from using telecommunication devices such as cell phones, camera/video, and iPad/Tablets during the instructional school day and will be confiscated if found in violation of our campus procedures.

Cell phones will be returned to the parent/guardian for a <u>\$15</u> administrative fee.

Nuisance items such as, earbuds/ear pods, will be confiscated if used on campus during the school day and will need to be picked up by a parent/guardian.

Teachers will require students to place electronic devices in their backpacks for the duration of the school day, which will be placed in a designated area in the classroom upon entry.

Students without backpacks will be required to place their electronic device in the teacher's designated container upon entry of class and will be returned at the end of the period.

\*Cell phones are <u>not</u> allowed to be used for instructional purposes.

\*District personnel will not assume responsibility for damaged, lost or stolen items.
