

In addition, it is worth mentioning that the evaluating committee was comprised of our own internal procurement professionals.

One of the examples of their excellent service is that they offer high-demand digital products in lower-priced packages. This has been highly appreciated through market research and has contributed to their popularity. According to a survey conducted by GradImages, a leading provider of commencement photography services, 90% of graduates prefer digital photos over printed ones.
