On September 14, 2022, the Community Programs department submitted a request to the purchasing department to issue a request for proposal 23-03-9115RFP for the department's online childcare registration and management software. A committee was formed to evaluate all submissions and is recommending GTSoft Inc. to be awarded the contract as the district's provider for the Community Programs department online childcare registration and management software.

The contract would be effective from July 1, 2023 through June 30, 2024 with the option to renew for four (4) additional one-year terms through June 30, 2028.

The committee believes the district will have the most favorable position with awarding the contract to GTSoft Inc. based on the comparisons with other proposers, selection criteria, software features, operational impact, and overall cost. GTSoft Inc. has had an ongoing relationship with the Community Programs department and has demonstrated the ability to provide excellent customer service and the ability to meet the district's needs.
