

2023-24 CHANGE OF RESIDENCE TRANSFER REQUEST

Currently enrolled CFISD students who move after the first day of school may use this form to request a transfer to remain at their previous campus. Families who have a signed contract on a home within CFISD may also use this form to request a transfer to attend school at the CFISD campus that is zoned for their new address.

Documentation of a parent/guardian's current residence is required to process this transfer request. Please include one item from Line A and one item from Line B.

- **Line A.** Your current lease, HCAD, mortgage statement, or closing documents
- **Line B.** Your current gas, water, or light bill.

When the transfer request is for a student that is moving into the zone, the parent/guardian will also be asked to provide a copy of a letter from their builder/leasing agent.

Parent/Guardian: Please complete one transfer application per child. Email the completed form and documentation of current residence to studenttransfers@cfisd.net. You will receive immediate confirmation that your email has been received and a decision via email within 10 business days of the office receiving the transfer request. Please note:

- Future requests for siblings to attend the same transfer campus are dependent on the open/closed status for a specific school year.
- Transfers are valid for the current school year and reviewed on a yearly basis.
- Transportation is not provided to/from the student's primary residence. Students may be transported to/from a state recognized childcare provider, parent, or grandparent responsible for providing before and after school care if there is a district-approved stop on a district-approved route serving the transfer campus.
- Transfer students in grades 9-12 are ineligible to participate in varsity athletics for one year from the first day of attendance at the transfer campus.
- If a student with an approved transfer is withdrawn from the transfer campus, the transfer will not be in effect if the student re-enrolls in the district.

REASON FOR REQUEST: (Please check one of the boxes below.)

- Moved **out** of attendance zone after August 28, 2023 and request to complete the current school year
- Student is still residing within the CFISD attendance boundaries. Students who have moved outside of CFISD will need to enroll in their new school district.

- Moving **into** the attendance zone after August 28, 2023
- Please attach a builder's letter with the expected closing date along with contract agreement. The estimated move-in date must be within 18 weeks from enrollment.
