Funding of School Districts

PROPERTY TAXES

- Values determined by Harris Central Appraisal District (HCAD)
- Tax rate comprised of:
 - ✓ Maintenance and Operations (M&O)
 - ✓ Interest and Sinking (I&S)
- M&O rate capped
 - ✓ Voter-Approval Tax Rate Election
- Optional homestead exemption
 - **✓** 20%

STATE AID

- Legislative state funding formula
 - ✓ Values determined by Comptroller
- Influenced by:
 - ✓ Enrollment
 - ✓ Average Daily Attendance (ADA)
 - Special populations
 - Enrichment pennies
 - Property wealth
- Not adjusted for inflation
 - ✓ Basic allotment = \$6,160



General Fund Expenditures



Teacher Retention House Approach*

- CSHB 100 by King Voted out of House 4-27-23
 - ✓ Basic Allotment (BA) increase \$140 over biennium
 - \$6,250 in FY 2023-2024
 - \$6,300 in FY 2024-2025



- o 75% of the 50% for teachers, counselors, nurses and librarians
- 25% of the 50% for non-administrative staff
- ✓ BA inflation factor based on 10-year average inflation rate
- √ 6th golden penny (without voter approval)
- ✓ Includes special education committee recommendations





Teacher Retention House Approach*

- CSHB 100 by King (cont'd)
 - Enrollment-based funding for most allotments in the second year of the biennium
 - Creates allotment for schools that provide an advanced math pathway
 - Creates allotment for fine arts
 - Creates allotment for book safety
 - ✓ Transportation allotment increased to \$1.54 per mile for regular route services and \$1.67 per mile for special education services
 - Small increase (0.0005 additional weight) in compensatory education allotment
 - Removes cap on the fast growth allotment

Increase in Campus Staff	\$14.6
Increase in Benefits & TRS	\$4.3
Increase in General Supplies (Inflation)	\$1.0
Increase in Utility Costs	\$1.6
Operating Costs to Open New Facilities	\$9.0
Net Increase in Property Insurance, Software Licenses, Contracted Services, Other Operating, etc.	\$5.8

Options for Budget 2023-2024



Increase the basic allotment and/or other state funding

> Requires legislative action

Modify adjustment to state property values for OHE

Requires legislative action



Remove portion or all of 20% OHE

Requires Board approval and notification to appraisal district prior to July 1, 2023



Increase Maintenance and Operations tax rate

➤ Requires Voter-Approval Tax Rate Election



Utilize remaining federal stimulus funds to help offset deficit

Requires Board of Trustees approval



Utilize fund balance

Requires Board of Trustees approval



Cut expenditures

➤ Requires Board of Trustees approval




MESSAGES TO LEGISLATORS
