

Resolution of the Board Regarding Hazardous Traffic Conditions For the 2022/2023 School Year

WHEREAS, Education Code 42.155(d) allows the Board of Trustees of Cypress-Fairbanks Independent School District to obtain supplemental state funding for transporting regular, otherwise ineligible students who live within two miles of their school but who would be subject to hazardous traffic conditions if they walked to school;

WHEREAS, the TEA handbook on School Transportation Allotments requires the Board to adopt language providing the definition of hazardous traffic conditions applicable to the District and identifying the specific hazardous areas for which such funding is requested;

WHEREAS, the Board acknowledges the Education Code 42.155(d) provisions stating that a hazardous condition exists where no walkway is provided and students must walk along or cross a freeway or expressway, an underpass, an overpass or a bridge, a major traffic artery, an industrial or commercial area, or another comparable condition;

NOW THEREFORE BE IT RESOLVED that the Board of Trustees of Cypress-Fairbanks Independent School District has defined hazardous traffic conditions as areas where no safe walk path is provided and students must walk along or cross a freeway or expressway, an underpass, an overpass or a bridge, a major traffic artery or another comparable condition the district has identified the following specific hazardous areas in which such conditions exist:

ELEMENTARY SCHOOL CAMPUSES:

1. **Adam** - Located at 11303 Honeygrove. All areas within two miles from Adam which would require students to walk along or cross North Eldridge Parkway, FM 1960 West, or Cypress North Houston Road, which are four-lane, moderately to heavily traveled thoroughfares.
2. **Andre** – Located at 8111 Fry Rd. All areas within two miles from Andre, since the campus is fronted by Fry Road, a four-lane, moderately to heavily traveled thoroughfare.
3. **Ault** - Located at 21010 Maple Village Dr. All areas within two miles from Ault which would require students to walk along or cross Mason Rd., Cypresswood Dr. or Fairfield Place Dr., which are all moderately to heavily traveled thoroughfares.
4. **Bane** – Located at 5805 Kaiser. All areas within two miles from Bane which would require students to walk along or cross Fairbanks North Houston, West Tidwell Road, West by Northwest Road, Hempstead Highway or US 290, which are all heavily traveled thoroughfares.
5. **Bang** – Located at 8900 Rio Grande. All areas within two miles from Bang which would require students to walk along or cross West or Jones roads, which are both four-lane, divided moderately to heavily traveled thoroughfares.
6. **Birkes** – Located at 8500 Queenston Rd. All areas within two miles from Birkes since the campus is bordered by Queenston and West roads, which are both four-lane, divided moderately to heavily traveled thoroughfares.
7. **Black** – Located at 14155 Grant Rd. All areas within two miles from Black which would require students to walk along or cross Grant or Spring Cypress roads, which are both moderately to heavily traveled thoroughfares.
8. **Copeland** – Located at 18018 Forest Heights Dr. All areas within two miles from Copeland which would require students to walk along or cross Barker Cypress Road, or to cross

- Longenbaugh Road or Queenston Boulevard, which are all four-lane, divided moderately to heavily traveled thoroughfares.
9. **Danish** – Located at 11850 Fallbrook Dr. All areas within two miles from Danish, since the campus is fronted by Fallbrook Drive, a four-lane, divided moderately to heavily traveled thoroughfare.
 10. **Duryea** – Located at 20150 Arbor Creek Dr. All areas within two miles from Duryea which would require students to walk along or cross Fry or West Little York roads or FM 529, which are all moderately to heavily traveled thoroughfares.
 11. **Emery** – Located at 19636 Plantation Myrtles Dr. All areas within two miles from Emery which would require students to cross Fry or West Little York roads, which are both four-lane, divided moderately to heavily traveled thoroughfares.
 12. **Emmott** – Located at 11750 Steepleway Blvd. All areas within two miles from Emmott which would require students to walk along or cross Jones Road, Fallbrook Drive, FM 1960 West, North Eldridge Parkway or West Road, which are all four-lane, divided moderately to heavily traveled thoroughfares.
 13. **Farney** – Located at 14425 Barker Cypress Rd. All areas within two miles from Farney which would require students to walk along or cross E. Louetta Rd./Huffmeister Rd. or Skinner Rd., both moderately to heavily traveled thoroughfares or to cross Barker Cypress Road, a divided moderately to heavily traveled thoroughfare.
 14. **Fiest** – Located at 8425 Pine Falls. All areas within two miles from Fiest which would require students to cross West Road, a moderately to heavily traveled thoroughfare.
 15. **Francone** – Located at 11250 Perry Rd. All areas within two miles from Francone since the campus is fronted by Perry Road, which is a moderately to heavily traveled thoroughfare.
 16. **Frazier** – Located at 8300 Little River Rd. All areas within two miles from Frazier which would require students to walk along or cross Fairbanks North Houston, which is a four-lane, divided moderately to heavily traveled thoroughfare.
 17. **Gleason** – Located at 9203 Willowbridge Park. All areas within two miles from Gleason which would require students to walk along or cross West Road, a four-lane, divided moderately to heavily traveled thoroughfare or to walk along or cross Sam Houston Parkway, a major traffic artery.
 18. **Hairgrove** – Located at 7120 No. Eldridge Pkwy. All areas within two miles from Hairgrove, since the campus is bordered by North Eldridge Parkway and FM 529, both four-lane, divided moderately to heavily traveled thoroughfares.
 19. **Hamilton** – Located at 12050 Kluge Rd. All areas within two miles from Hamilton, since the campus is bordered by Old Kluge and Grant roads, which are both moderately to heavily traveled thoroughfares.
 20. **Hancock** – Located at 13801 Schroeder Rd. All areas within two miles from Hancock that would require students to walk along or cross Schroeder Road, a moderately to heavily traveled thoroughfare or to walk along or cross Cypresswood Drive or FM1960, both a divided heavily traveled thoroughfare, or to walk along or cross US Highway 249, a major traffic artery.
 21. **Hemmenway** – Located at 20400 West Little York Rd. All areas within two miles from Hemmenway since the campus is fronted by West Little York Road, which is a divided, moderately to heavily traveled thoroughfare.
 22. **Holbrook** – Located at 6402 Langfield Rd. All areas within two miles from Holbrook since the campus is fronted by Langfield Road, which is a moderately to heavily traveled thoroughfare.

23. **Holmsley** – Located at 7315 Hudson Oak Dr. All areas within two miles from Holmsley which require students to cross Barker Cypress Road, FM 529, or Queenston Boulevard, which are four-lane, moderately to heavily traveled thoroughfares.
24. **Hoover** – Located at 6425 Greenhouse Rd. All areas within two miles from Hoover which would require students to walk along or cross Greenhouse or West Little York roads, which are both moderately to heavily traveled thoroughfares.
25. **Horne** – Located at 14950 W. Little York Rd. All areas within two miles from Horne which would require students to walk along or cross Addicks Satsuma, Huffmeister or West Little York roads, which are all moderately to heavily traveled thoroughfares.
26. **Jowell** – Located at 6355 Greenhouse Rd. All areas within two miles from Jowell which would require students to walk along or cross Greenhouse or West Little York roads, which are both moderately to heavily traveled thoroughfares.
27. **Keith** – Located at 20550 Fairfield Green. All areas within two miles from Keith which would require students to cross Fairfield Green or walk along or cross Mason, Mueschke or Schiel roads, which are all moderately to heavily traveled thoroughfares.
28. **Kirk** – Located at 12421 Tanner Rd. All areas within two miles from Kirk which would require students to walk along or cross North Eldridge Parkway or Tanner Road, which are both four-lane, moderately to heavily traveled thoroughfares.
29. **Lamkin** – Located at 11521 Telge Rd. All areas within two miles from Lamkin since the campus is bordered by Cypress North Houston and Telge Road, which are both four-lane, moderately to heavily traveled thoroughfares.
30. **Lee** – Located at 12900 West Little York. All areas within two miles from Lee which would require students to walk along or cross West Little York or North Eldridge Parkway, or Hempstead Hwy which are both four-lane, divided moderately to heavily traveled thoroughfares or walk along Emmett Rd. a two-lane moderately traveled throughfare with no walk path.
31. **Lieder** – Located at 17003 Keith Harrow Blvd. All areas within two miles from Lieder which would require students to walk along or cross Keith Harrow, a moderately to heavily traveled throughfare.
32. **Lowery** – Located at 15950 Ridge Park. All areas within two miles from Lowery which would require students to cross FM 529 or Longenbaugh Road, both four-lane, moderately to heavily traveled thoroughfares.
33. **Matzke** – Located at 10002 Mills Rd. All areas within two miles from Matzke since the campus is fronted by Mills Rd., a moderately to heavily traveled thoroughfare.
34. **McFee** – Located at 19315 Plantation Cove. All areas within two miles from McFee which would require students to walk along or cross West Little York or Greenhouse roads, which are all moderately to heavily traveled thoroughfares.
35. **McGown** – **Located at 21211 Tuckerton Rd.** All areas within two miles from Elementary #57 which would require students to cross Tuckerton Rd. or Westgreen Blvd., both four-lane, divided moderately to heavily traveled throughfares.
36. **Metcalf** – Located at 6100 Queenston. All areas within two miles from Metcalf which would require students to walk along or cross Queenston Boulevard or West Little York, which are both four-lane, moderately to heavily traveled thoroughfares.
37. **Millsap** – Located at 12424 Huffmeister. All areas within two miles from Millsap which would require students to walk along or cross Huffmeister Road, Cypress North Houston or North Eldridge Parkway, which are all four-lane, moderately to heavily traveled thoroughfares.

38. **Moore** – Located at 13734 Lakewood Forest Dr. All areas within two miles from Moore which would require students to walk along or cross Grant Road or Cypresswood Drive, which are both moderately to heavily traveled thoroughfares.
39. **Owens** – Located at 7939 Jackrabbit Rd. All areas within two miles from Owens which would require students to walk along or cross Jackrabbit Rd or Huffmeister Rd., which are both moderately to heavily traveled thoroughfares, or to walk along or cross West Rd. or FM 529, which are both four to six lane divided heavily traveled thoroughfares.
40. **Pope** – Located at 19019 N. Bridgeland Lake Pkwy. All areas within two miles from Pope which would require students to cross North Bridgeland Lake Parkway which is a moderately to heavily traveled thoroughfare.
41. **Post** – Located at 7600 Equador. All areas within two miles from Post which would require students to walk along or cross Beltway 8, or walk along US290, which are both major traffic arteries or to cross Senate, a four-lane, divided moderately to heavily traveled thoroughfare.
42. **Postma** – Located at 18425 West Rd. All areas within two miles from Postma, since the campus is bordered by West and Greenhouse roads, which are both four-lane, divided moderately to heavily traveled thoroughfares.
43. **Reed** – Located at 8700 Tami Renee Lane. All areas within two miles from Reed which would require students to walk along or to cross Rodney Ray or Fairbanks North Houston, which are both four-lane, moderately to heavily traveled thoroughfares.
44. **Rennell** – Located at 19500 Tuckerton Blvd. All areas within two miles from Rennell which would require students to walk along or cross Tuckerton Rd. or to cross Greenhouse Rd. which are both four lanes divided moderately to heavily traveled thoroughfares or to cross Cypress North Houston, a moderately to heavily traveled thoroughfare.
45. **Robinson (M.)** - Located at 4321 Westfield Village Dr. All areas within two miles from M. Robinson since the campus is bordered by Clay Road and Westfield Village Drive, which are both divided, moderately to heavily traveled thoroughfares.
46. **Robison (A.)** – Located at 17100 Robison Woods Rd. All areas within two miles from Robison since the campus is bordered by Skinner, Jarvis and Spring Cypress roads, which are all moderately to heavily traveled thoroughfares.
47. **Sampson** – Located at 16002 Coles Crossing Dr. All areas within two miles from Sampson which would require students to walk along Spring Cypress Rd. or walk along or cross Barker Cypress Rd. and Telge Rd, which are all four-lane divided heavily traveled thoroughfares, or walk along or cross Huffmeister Rd. or Jarvis Rd., which are both moderately to heavily traveled thoroughfares.
48. **Sheridan** – Located at 19790 Keith Harrow Blvd. All areas within two miles from Sheridan since the campus is fronted by Keith Harrow, a four-lane, divided moderately to heavily traveled thoroughfare.
49. **Swenke** – Located at 22400 Fairfield Place Dr. All areas within two miles from Swenke which would require students to cross Fairfield Place Dr., a four-lane, divided moderately to heavily traveled thoroughfare or to walk along or cross Schiel Rd., a rural moderately to heavily traveled thoroughfare.
50. **Tipps** – Located at 5611 Queenston Blvd. All areas within two miles from Tipps since the campus is fronted by Queenston Boulevard, a four-lane, divided moderately to heavily traveled thoroughfare.
51. **Walker** – Located at 6424 Settlers Village. All areas within two miles from Walker which would require students to walk along or cross FM 529, West Little York or Fry roads, which are all moderately to heavily traveled thoroughfares.

52. **Warner** - Located at 10400 Warner Smith Blvd. All areas within two miles from Warner which would require students to cross or walk along Tuckerton or Fry Rd., which are four-lane, divided moderately to heavily traveled thoroughfares, or to cross Cypress North Houston, a moderately to heavily traveled thoroughfare.
53. **Wells** – Located at 10607 Mason Rd. All areas within two miles which would require students to cross Mason Rd, Tuckerton Rd., or Bridgeland Creek Pkwy, all four-lane, divided moderately to heavily traveled thoroughfares.
54. **Willbern** – Located at 10811 Goodspring Dr. All areas within two miles from Willbern which would require students to walk along or cross Fallbrook Road, Beltway 8, or Round Up Lane, which are all moderately to heavily traveled thoroughfares.
55. **Wilson** – Located at 18015 Keith Harrow Dr. All areas within two miles from Wilson which would require students to walk along or cross Keith Harrow Drive or Barker Cypress Road, which are both four-lane, moderately to heavily traveled thoroughfares or to walk along or cross Windsong Trails, a moderately to heavily traveled thoroughfare.
56. **Woodard** – Located at 17501 Cypress North Houston Rd. All areas within two miles from Woodard which would require students to walk along or cross Queenston Blvd., Cypress North Houston and Barker Cypress Road, which are both four-lane, moderately to heavily traveled thoroughfares.
57. **Yeager** – Located at 13615 Champion Forest Dr. All areas within two miles from Yeager since the campus is fronted by Champion Forest Drive, a four-lane, moderately to heavily traveled thoroughfare.

MIDDLE SCHOOL CAMPUSES:

1. **Anthony** – Located at 10215 Greenhouse Rd. All areas within two miles from Anthony which would require students to walk along or cross Tuckerton Rd. or to cross Greenhouse Rd. which are both four lanes divided moderately to heavily traveled thoroughfares or to cross Cypress North Houston, a moderately to heavily traveled thoroughfare.
2. **Aragon** – Located at 16823 West Rd. All areas within two miles from Aragon since the campus is bordered by Queenston and West roads, which are both moderately to heavily traveled four-lane, divided thoroughfares.
3. **Arnold** – Located at 11111 Telge Road. All areas within two miles of Arnold, since the campus is bordered by Cypress North Houston, Telge Road and US 290 feeder, which are all moderately to heavily traveled thoroughfares.
4. **Bleyl** – Located at 10800 Mills Rd. All areas within two miles from Bleyl which would require students to walk along or cross Jones, Grant, Mills or Perry roads which are all moderately to heavily traveled thoroughfares.
5. **Campbell** – Located at 11415 Bobcat Rd. All areas within two miles from Campbell since the campus is bordered by Windfern and Bobcat roads, which are both moderately to heavily traveled thoroughfares.
6. **Cook** – Located at 9111 Wheatland. All areas within two miles from Cook which would require students to walk along or cross West or Jones roads, or Beltway 8, which are all divided, moderately to heavily traveled thoroughfares.
7. **Dean** – Located at 14104 Reo St. All areas within two miles from **Dean** which would require students to walk along or cross Fairbanks North Houston, West Tidwell Road, West by Northwest Road, Hempstead Highway or US 290, which are all moderately to heavily traveled thoroughfares.

8. **Goodson** – Located at 17333 Huffmeister. All areas within two miles from Goodson which would require students to walk along or cross Grant Rd., Telge Rd., Skinner Rd., E. Louetta Rd./Huffmeister Rd., which are all moderately to heavily traveled thoroughfares or to cross Barker Cypress Road, a divided moderately to heavily traveled thoroughfare.
9. **Hamilton** – Located at 12330 Kluge Road. All areas within two miles from Hamilton since the campus is bordered by Kluge and Grant roads, which are both moderately to heavily traveled thoroughfares.
10. **Hopper** – Located at 7811 Fry Road. All areas within two miles from Hopper since the campus is fronted by Fry Road, a four-lane divided, moderately to heavily traveled thoroughfare.
11. **Kahla** – Located at 16212 West Little York. All areas within two miles from Kahla which would require students to cross West Little York, which is a four-lane, moderately to heavily traveled thoroughfare or require students to walk along or cross Queenston, a four-lane, divided moderately to heavily traveled thoroughfare.
12. **Labay** – Located at 15435 Willow River. All areas within two miles from Labay which would require students to cross West Road or State Highway 6, which are both divided, moderately to heavily traveled thoroughfares.
13. **Rowe** – Located at Located at 19 Westgreen Blvd. All areas within two miles of Rowe, since the campus is bordered by Westgreen Blvd. and FM 529, which are divided, moderately to heavily traveled thoroughfares.
14. **Salyards** – Located at 21757 Fairfield Place Drive. All areas within two miles from Salyards which would require students to cross Fairfield Place Drive, Cypresswood Dr., or Cumberland Ridge, four-lane, divided, moderately to heavily traveled thoroughfares.
15. **Smith** – Located at 10300 Warner Smith Blvd. All areas within two miles from Smith which would require students to cross or walk along Tuckerton or Fry Rd., which are four-lane, divided moderately to heavily traveled thoroughfares, or to cross Cypress North Houston, a moderately to heavily traveled thoroughfare.
16. **Spillane** – Located at 13403 Woods Spillane Blvd. All areas within two miles from Spillane since the campus is bordered by Skinner, Jarvis and Spring Cypress roads, which are all moderately to heavily traveled thoroughfares.
17. **Thornton** – Located at 19802 Keith Harrow Blvd. All areas within two miles from Thornton since the campus is fronted by Keith Harrow, which is a four-lane, divided moderately to heavily traveled thoroughfare.
18. **Truitt** – Located at 6600 Addicks Satsuma Rd. All areas within two miles from Truitt which would require students to walk along or cross Addicks Satsuma, West Little York or Huffmeister roads, which are all moderately to heavily traveled thoroughfares.
19. **Watkins** – Located at 4800 Cairnvillage. All areas within two miles from Watkins which would require students to walk along or cross Keith Harrow or Stacey Rd south of Glencarin, which are moderately to heavily traveled thoroughfares.

HIGH SCHOOL CAMPUSES:

1. **Bridgeland** – Located at 10707 Mason Rd. All areas within two miles which would require students to cross Mason Rd, Tuckerton Rd., or cross or walk along Bridgeland Creek Pkwy, all four-lane, divided moderately to heavily traveled thoroughfares.
2. **Cy-Fair** – Located at 22602 Hempstead Hwy. All areas within two miles of Cy-Fair, since the campus is bordered by Cypress North Houston, Telge Road and US 290 feeder, which are all divided, moderately to heavily traveled thoroughfares.

3. **Cypress Creek** – Located at 9815 Grant Rd. All areas within two miles of Cypress Creek, since the campus is bordered by Grant and Perry roads, which are both moderately to heavily traveled thoroughfares.
4. **Cypress Falls** – Located at 9811 Huffmeister Rd. All areas within two miles of Cypress Falls which would require students to walk along or cross Tuckerton Rd., Telge Rd., West Rd., Huffmeister Rd., State Highway 6/FM 1960, or US 290 feeder all of which are four to six lanes divided moderately to heavily traveled thoroughfares or to walk along Hempstead Hwy, a moderately to heavily traveled thoroughfare.
5. **Cypress Lakes** – Located at 5750 Greenhouse Rd. All areas within two miles from Cypress Lakes which would require students to walk along or cross Greenhouse Road, which is a moderately to heavily traveled thoroughfare.
6. **Cypress Park** – Located at 7425 Westgreen Blvd. All areas within two miles of Cypress Park, since the campus is bordered by Westgreen Blvd. and FM 529, which are divided, moderately to heavily traveled thoroughfares.
7. **Cypress Ranch** - Located at 10700 Fry Rd. All areas within two miles from Cypress Ranch which would require students to cross or walk along Tuckerton Rd. or Fry Rd., which are four-lane, divided moderately to heavily traveled thoroughfares, or to cross Cypress North Houston which is a moderately to heavily traveled thoroughfare.
8. **Cypress Ridge** – Located at 7900 N. Eldridge Pkwy. All areas within two miles from Cypress Ridge, since the campus is fronted by North Eldridge Parkway, which is a four-lane, divided moderately to heavily traveled thoroughfare.
9. **Cypress Springs** – Located at 7909 Fry Rd. All areas within two miles from Cypress Springs, since the campus is fronted by Fry Road, which is a divided, moderately to heavily traveled thoroughfare.
10. **Cypress Woods** – Located at 13550 Woods Spillane Blvd. All areas within two miles from Cypress Woods, since the campus is bordered by Skinner, Jarvis and Spring Cypress roads, which are all moderately to heavily traveled thoroughfares.
11. **Jersey Village** – Located at 7600 Solomon St. All areas within two miles from Jersey Village which would require students to walk along or cross Beltway 8, or walk along US290, which are both major traffic arteries or to cross Senate, a four-lane, divided moderately to heavily traveled thoroughfare.
12. **Langham Creek** – Located at 17610 FM 529. All areas within two miles from Langham Creek which would require students to walk along or cross FM 529 or Barker Cypress Road, or cross Queenston Boulevard or Longenbaugh Road, which are all four-lane, divided moderately to heavily traveled thoroughfares.
