- III. Classroom Door Audit
- IV. Weekly Exterior Door Sweeps Audit

Mr. Hudson presented the findings of each of the eleven audited campuses.

## **Consider adoption of the Intruder Detection Audit Corrective Action Plans**

Once all the findings were presented and discussed, Mr. Hudson called for a motion to end the closed session. Lynn Blakeslee initiated the motion, and Gary Kinninger seconded.
