I understand that college level standards of conduct are required, and it is my responsibility to comply with the minimum standards, student code of conduct policies, academic standards of LSC, and standards set forth in the course syllabus. I understand that college level parking requirements will be met. I also understand that borrowing to finance courses could negatively affect financial aid, scholarships, future enrollment, tuition costs, etc.

I, as the parent or legal guardian of the above named Student and I have read and understand the above statement and agree to the terms and stipulations. I hereby grant my consent for the above named Student to enroll as a student at LSC.

I understand that although LSC will, as necessary, LSC does not use parent/guardian to provide additional or replacement credit towards the way going on individual on campus.

All students age sixteen (16) years or younger must have a parent/legal guardian, or authorized representative while while at a LSC college, rooms, or facilities at all times to ensure the student's welfare outside of class and to be immediately available in case of an emergency. I further have a parent or legal guardian at the LSC college, rooms, or facilities, and agree that I will be immediately available to the student.

In consideration of Student being permitted to participate as a student at LSC and use the LSC facilities ("facilities"), I, on behalf of Student, hereby assume all risks of injury, illness, death, or other loss arising from or in any way relating to Student's participation as a student on any of the facilities. I acknowledge that Student's use of the facilities may expose Student to hazards or risks that may result in Student's illness, personal injury, or death, and I understand and appreciate the nature of such hazards and risks.

On behalf of myself, Student, family, heirs, and personal representatives, I hereby release LSC, its governing board, officers, employees, and management, collectively the "Releasees", from any and all liability to me, Student, personal representatives, heirs, family, heirs, and all, and agree to hold all Releasees harmless for any and all claims that I or others file for or through Releasees' negligence and for any and all claims or injury to include, but not limited to, death, that may result from or arise during participation in use of the facilities, whether caused by negligence of the Releasees, or otherwise. I further agree to defend and hold Releasees harmless from liability for the injury or death of any person's and damage to property that may result from Student's negligent or intentional or in negligence while participating in using the facilities. I understand and agree that Releasees are not held personally responsible.


I further agree that this Release shall be considered in accordance with the laws of the State of Texas. If any terms or provisions of this Release shall be held illegal, unenforceable, or in conflict with any law governing the Release, the validity of the remaining portions shall not be affected hereby.
