Parent/Guardian: Please complete one transfer request per child. The request along with the supporting documents may be sent to studenttransfers@cfisd.net. You will receive immediate confirmation that your email has been received. For your convenience, you may also deliver the completed transfer request and supporting documentation to your child's current campus registrar or directly to the Office of Student Services/Admissions. You will receive a decision via email within 10 business days of the office receiving the transfer application. Please note:

- Transfers are valid for the current school year and reviewed on a yearly basis. Principals review student's attendance and/or factors that may impact safety and/or academic progress.
- Transportation is not provided to/from the student's primary residence. Students may be transported to/from a state recognized childcare provider, parent, or grandparent responsible for providing before and after school care if there is a district-approved stop on a district-approved route serving the transfer campus.
- Transfer students in grades 9-12 are ineligible to participate in varsity athletics for one year from the first day of attendance at the transfer campus.
- If a student with an approved transfer is withdrawn from the transfer campus, the transfer will not be in effect if the student reenrolls in the district.
- Future requests for siblings to attend the same transfer campus are dependent on the open/closed status for a specific school year.

REASON FOR REQUEST: (Check One)

- Moved **out** of attendance zone after September 8, 2020

 - Students who have moved outside of the CFISD boundary zones and students who will be entering all other grade levels will need to enroll at their home campus.
- Moving **into** the attendance zone after September 8, 2020
- Current CFISD residents, in addition to your current proof of residency, please attach a builder's letter with the expected closing date along with contract agreement. The estimated move-in date must be within 18 weeks from enrollment.
 - Non-CFISD residents, in addition to your current proof of residency, please attach a builder's letter with the expected closing date along with contract agreement indicating that the estimated move-in date will be within 18 weeks from enrollment. The Office of Student Services/Admissions will contact you regarding the tuition payment.
